RELEASE, INDEMNITY AND LIMITATION OF LIABILITY AGREEMENT

In the event that the Rodeo, is found to be liable to Participant to any extent for any reason arising out of my participation in the Rodeo, resulting from any negligent acts, errors and/or omissions of Rodeo, I knowingly, voluntarily and without undue influence, agree that any damages shall be limited to no more than Five Hundred Dollars (\$500.00).
